Job Description:

All American Co-op is looking for a detail oriented individual(s) to perform daily feed mill production and operations functions. All team members are expected to follow quality feed production practices performed in a clean, safe, efficient manner to benefit All American Co-op and its customers. Qualifying individual must be a motivated self-starter that is willing to work in a team setting.

Job Responsibilities

- Operate feed mill computer system, which includes batch mixing, liquid applications, pelleting, scaling ingredients, grinding, bagging, and receiving systems.
- Measure physical inventory of bulk feed ingredients & packaging materials including bags, supplies, and tags.
- Perform quality control functions, which include monitoring feed and feed ingredients, to ensure quality and safety requirements are met and comply with industry standards.
- Monitor drug inventory and usage in accordance with procedures required by HACCP procedures and regulatory agencies.
- Load and unload incoming and outgoing ingredients and feed mixes, both bulk and bagged products.
- Operate soybean roaster and all functions pertaining to it to ensure that we are meeting quality control standards and guidelines.
- Comply with and monitor all procedures and regulations that are required by HACCP and other feed industry standards.
- Perform facility maintenance and housekeeping throughout the feed mill.
- Must have basic mechanical/electrical aptitude, must have efficient problem solving skills with a critical thought process to fix things on the spot while keeping feed mill operations moving.
- Must maintain equipment, keep complete maintenance records, and meet all required maintenance guidelines.
- Communicate effectively in order to provide employees and customers with the right product, delivered to the right locations, at the right time.
- Must be willing to work in high places and in confined spaces and follow OSHA safety rules.
- Must be able to work independently and as a team, assist co-workers when needed, and fill in when others are absent.
- Must be willing to work overtime when needed.
- Greet ALL customers promptly and in a courteous manner At All Times!
- Occasional delivering of bulk and bagged feed products to All American Co-op customers and branch locations.

Job Requirements

- Must have basic computer skills and be willing to learn new skills and technologies as needed.
- A CDL with necessary endorsements is preferred.
- Must be able to operate a forklift, a pallet jack, and a handcart.
- Weight carried, moved or lifted unassisted frequently 1-100 lbs
- Weight carried, moved or lifted with assistance 100-250 lbs.
- Maneuver up to 600 lbs with a handcart.
- Must wear protective equipment necessary (i.e.: Dust Mask, Goggles, Ear Plugs, etc...)
